Queen's Park Primary School – Mobile Phone Policy

1. Purpose and Scope

Queen's Park Primary School is committed to providing a calm, safe and supportive environment conducive to teaching and learning. As part of this commitment, the school requires that **mobile phones and devices with similar functionality are not brought on site by pupils**. This supports our core purpose of protecting children's wellbeing and maintaining focus on learning.

2. Policy Statement

In line with the Department for Education's expectations, Queen's Park Primary School maintains a **mobile phone-free environment for all pupils throughout the school day**, including during lessons, breaktimes and lunchtime.

3. Definition

For the purpose of this policy, *mobile phone* includes any personal device capable of communication or recording (e.g., voice calls, text, email, internet access, audio or video recording).

4. Expectations for Pupils

- Pupils are **not permitted to bring mobile phones or similar devices on site** at any time.
- Pupils must comply with this requirement and hand over any mobile phone found on site at the start of each day.
- Pupils should be taught the risks associated with mobile phone use and understand the reasons for this prohibition, including reducing distraction, disruption, and safeguarding concerns.

5. Role of Parents and Carers

- Parents/carers are expected to **support and reinforce the school's mobile phone-free policy**.
- If parents need to contact their child during the school day, they should do so via the school office, which will support communication in line with this policy.
- Parents should not arrange for children to bring mobile phones to school for personal use.

6. Role of Staff

- All staff are responsible for consistently enforcing this policy and ensuring pupils comply.
- Staff should not use personal mobile phones for non-school work in front of pupils during the school day to model appropriate behaviour.

7. Sanctions

Mobile Phone Policy

- Failure to comply with this policy may result in sanctions in line with the school's Behaviour Policy. This includes the lawful **confiscation of mobile phones or similar devices** if found on site.

8. Exceptional Circumstances

- Requests for exceptions (e.g., for medical reasons) must be made in writing and agreed with the Headteacher.
- Any adjustments considered will comply with the school's duties under equality and safeguarding legislation
